### **SPIRITUALITY:**

Being a Christian is not about religion, but about a relationship with my Lord and Savior, Jesus Christ. While I have been serving a life sentence at SCI Muncy, I participated in Yokefellow Prison Fellowship, Bible Studies, Life in the Spirit, Midweek Prayer, Sunday morning and afternoon worship services, and I have also had the privilege to attend Catholic Mass.

Since being at SCI Cambridge Springs, I attend Saturday morning and Sunday evening services. I have been a part of a worship team called, "Gatekeepers." I have attended Women's Aglow International Fellowship, Mom's in Touch prayer group, independent Bible Studies, Spiritual Maturity Bible Study, Kairos Retreat and update-Metanoia Retreat. I currently sing on the Protestant Choir and have had the opportunity to direct the choir and am the worship leader. I attend United Fellowship Bible Studies on the 2nd and 4th Tuesday of the month and have attended many speaking engagements and seminars through the religious services area. I also participated in a journaling seminar led by Sister Natalie Rossi.

### **HEALTH REPORT (2018)**

I am healthy as an ox! However, I take high blood pressure and cholesterol medication. I have just the normal aches and pains that come with aging. I still exercise every day and work with the dogs. Plus, my detail is one that can be physically demanding.

#### THE WOMAN I AM NOW:

When I first came to prison, I was only a shell of a woman. I was broken, abused, had low self-esteem and I thought of myself as a victim. The years I have spent behind bars has revealed the person I am. I am no longer a victim but a victor. I am no longer broken, rather, I am mended. No longer do I have low self-esteem; I have strength, courage, and like a Phoenix rising out of the ashes, I have risen above circumstances.

I am a leader. I have ceased hiding in the shadows and embrace the front line. The face that had no voice, is no longer silenced, but speaks with truth and conviction. The woman I am now is proud of who she has become and now that woman who looks back at her in the mirror, can smile and say, "I love you and I celebrate you." As Helen Reddy sang, "I am woman. Hear me roar!" Today, I can tell you that I LOVE MYSELF AND THE LORD. I am not angry or mad at the world or the cards that I have been dealt. Being inside these walls has given me the opportunity to meet so many wonderful people from all walks of life. They have told me that I inspire them, but really, it is me who is inspired the most.
