Dear Members of the Women Lifers Resume Project of PA,

I am writing on behalf of Marie Scott, #004901, who is incarcerated at SCI Muncy with a life sentence. I am a member of the Pennsylvania Prison Society, and have visited Marie since the 1990's. I believe that Marie deserves a second change of joining society as a contributing citizen.

Marie has completed almost all the programs offered by SCI Muncy to improve her education and social ability. She has completed many rehabilitative courses: Understanding Relationships, Out-Patient Drug and Alcohol Therapy, In-Patient Sexual Assault, Impact of Crime, Drug, and Alcohol Education, In-Patient Domestic Violence, Anger Management, Assertiveness, Breaking Barriers, Basic Communication, Citizenship, In-Patient Drug and Alcohol, Per Facilitation, and HIV/Hepatitis Education. She has also received an Associate Degree in Sociology from Penn State University. She is now permitted to teach Anger Management to the inmates, and facilitates the following programs: Citizenship, National Issues Forums, HIV/Hepatitis, Narcotics Anonymous, Alcoholics, Alanon Anonymous, and Special Needs. She has been chairperson of the Women's Restorative Justice Committee, and helps the Pennsylvania Prison Society with communication with inmates, victims, offenders, and their communities. Marie is the editor of "COPING" magazine, Children of Parent Inmates Needing Guidance: articles that Marie thought were a need for children whose parents were in prisons to help their anger and frustration at being separated from their parents. Parents and children can write letters to the news magazine to get answers to issues and concerns that they hesitate to discuss with their caregivers.

Marie has been invited to California to visit Director Denise Johnson, the person who runs the center in United States for children of incarcerated parents. If Marie were released, she would like to bring this program to Pennsylvania.

Marie was honored as the Pennsylvania Prison Society's "Prisoner of the Year" in 1996, and was escorted to Philadelphia by the Superintendent of SCI Muncy to accept the award. She is one of the most resourceful and energetic persons that I have meet in the prison system. Despite her childhood experiences in growing up in an abusive environment, she deeply regrets the criminal incident that she participated in as a teenager. Marie continues to improve herself at SCI Muncy, and is working with training service dogs to help people with disabilities that will need them. She continues to have hope that one day she can return to society and become a contributing citizen. She wants to help others by sharing her story to people who may be experiencing things in their environment that could drive them to crime, and hopefully help them improve their lives.

I know if Marie Scott were given another chance at life through the parole of her sentence, she would be a successful citizen of her community.
