THE WOMAN I AM NOW:

At the initial onset of my life sentence, I experienced personal difficulties in adjusting due to my rebelliousness and peer pressure handicaps. I was angrier with myself than with the system for allowing myself to cause death. As time progressed, I realized that I had to face the responsibility of self-improvement. The thrust towards this goal came to me in degrees; depending on the amount of hope I had at that particular time. Sometimes the weight of this sentence became too overwhelming and it was during these times that I would shut down emotionally.

As I became more active in the church, I realized the beginning of my change in attitude. I was able to tie in all of my experiences from the various programs, educational opportunities and athletic teams I had been participating in. I've learned through numerous self-help groups to accept full responsibility for the acts I performed. I continue to experience extreme remorse and sorrow. My participation in numerous therapy groups has proven to be a great asset to my personal reconstruction.

I am the longest life sentence serving women in Pennsylvania. I am in my 43rd year of confinement. When I arrived at Muncy, there were no fences. At one point, I was a part of the varsity softball team. We played teams from neighboring communities and we went to their towns to compete. As the director of the chorus, we performed in local churches. As a result, I learned to appreciate not only the value of my life, but the lives of others as well. After so many years of doing this time and living my life to the fullest, my health is not great. I hope to one day be able to take care of my mother who has sacrificed so much for me.
